- In partnership with the client's Process Owner Team, responsible for safety oversight and policy administration, YASH solutions team finalized SAP EHSM solution model integrating with 3rd party / external applications.
- The solution is hosted in Microsoft Azure cloud platform for interlinking all geographical spread across 40 business sites and for the upcoming / new sites being acquired.
- EHS consultants / team from YASH, brought in significant experience in SAP technologies and SAP EHS implementations and required domain expertise.
- The solution has been implemented through two (2) phased approach for better adoption & ROI.

Phase I: <i>As per business priority, Incident Management & Environment Management were implemented in phase I.</i>	
Incident Management (IM)	Environment Management (EM)
Standardized EHS – Incident Reporting and Processing	Track Energy/Water/Fuel consumption, Waste generation from all business units each month and report into the standardized reporting template
Quick/Easy Incident reporting from desktop / mobile application	Control the release and consumptions exceedance by deviation reporting

Integration with Workday (HR system) was established with SAP system to have smooth flow of employee data /records

Integration with MSDS online tool for the business to access / generate updated SDS documents.

- Expanding the capabilities of the IM module by reclassifying the injury types, adding additional categories.
- Based on the engagement, the client requested a series of system enhancement and new leadership dashboards.
- Client is planning to replicate the success of the present Engagement in optimizing its maintenance operations.
- Regulatory compliance database to be integrated within the EHS systems to help monitor global compliance.
- In the upcoming projects, predictive maintenance driven through analytical insights will play a defining role.
